## IV Application for the 'Registration Certificate for Kindergarten Admission':

- 1. The Government have implemented 'Free Quality Kindergarten Education Scheme' (hereafter referred to as 'Scheme') starting from the 2017/18 school year. Each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-KGs can only admit students holding a valid registration document.
- 2. Parents are required to apply for the 'Registration Certificate for Kindergarten Admission' (hereafter referred as 'RC') to EDB <u>from September to November 2024</u>. The 'RC' will be open for applications in September 2024 and EDB will announce and upload the details of application onto EDB's website (https://www.edb.gov.hk/en/edu-system/preprimary-kindergarten/kindergarten-k1-admission-arrangements/front.html) in due course. Upon receipt of the applications with all necessary information and documents provided, EDB will generally take six to eight weeks to complete processing of the applications and issue the 'RC' to applicants who are eligible for receiving subsidy under the Scheme by post. If a student cannot obtain an 'RC' as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme¹, EDB will then issue a 'Kindergarten Admission Pass' (hereafter referred to as 'AP') to the student concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

Parents need to submit the original 2025/26 'RC' and pay the registration fee.
- 3. Please be reminded that if parents fail to submit the 'RC'/ 'AP' during registration, our kindergarten <u>cannot</u> register for the child. Therefore, parents <u>must</u> submit the applications for the registration documents to EDB within the specified period.

If the child studies in our kindergarten, the registration fee paid will be refunded in <a href="late-september-2025">late-september-2025</a>. If parents decide to decline the offer of the school place after registration, please notify our kindergarten in writing. The kindergarten will return the 'RC' / 'AP', but the registration fee will not be refunded. Upon obtaining the 'RC' / 'AP', the kindergarten will no longer reserve the school place for the child.
