## Notes on 2025/26 School Year Admission to K1 Classes

#### Collection of application Forms (No preset quota):

- 1. Download from school website
- 2. Obtain from school in person

#### **Application Forms Distribution Period:**

- 1. Date: Application starts from 3 June 2024 (Monday)
- 2. Time: 9:30 a.m. to 12:00 noon; 2:00 p.m. to 5:00 p.m., Mondays to Fridays

#### **Return of Application Forms (No preset quota):**

- 1. Date: Application starts from 3 June 2024 (Monday)
- 2. Time: 9:30 a.m. to 12:00 noon; 2:00 p.m. to 5:00 p.m., Mondays to Fridays
- 3. Application forms to be submitted <u>in person or by post</u>, together with the following documents required:
  - a. Completed application form with photos affixed;
  - b. A <u>copy</u> of the applicant's Hong Kong Birth Certificate or Certificate of Permant Residency
  - c. A **copy** of Vaccination Record (both the front and back pages)
  - d. **Four** return envelopes each completed with the mailing address, children's name and \$2.2stamp affixed
  - e. Application fee: HK\$40 (This is **non-returnable** whether the application is successful or not)

#### Remarks:

- 1. The Kindergarten, based on application response, will decide whether to continue the acceptance of application forms or not after the deadline.
- 2. Please present <u>all</u> the documents required, otherwise, we will not process your application.

# Application for the "2025/26 Registration Certificate for Kindergarten Admission"

Parents are required to apply for the "2025/26 Registration Certificate for Kindergarten Admission" (hereafter referred as "2025/26 RC") with EDB <u>from September to November 2024</u>. The "2025/26 RC" will be open for applications in September 2024 and EDB will announce and upload the details of application onto EDB's website in due course.

#### **Admission Criteria**

- 1. Interview performance
- 2. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration
- 3. Parents agree with the school's educational philosophy and be willing to co-operate
- 4. Live near the kindergarten or at a location that the school bus can reach
- 5. For applying <u>whole day classes</u>, applicants from families in need will be given due priority consideration

(However, as the number of relevant school places is limited, not all applicants fulfilling the priority consideration will be guaranteed a school place.)

#### **Interview Arrangements**

- 1. The kindergarten will arrange interviews for all applicants
- 2. The first round of interviews will be conducted on <u>2 November 2024 (Saturday)</u>. The kindergarten will notify parents of the exact time <u>by post</u>.
- 3. Individual and group interviews will be arranged
- 4. Parents **should** accompany their child for the interview

## Interview Arrangements for Non-Chinese Speaking (NCS) Children

When interviewing NCS children, the school can arrange simultaneous interpretation and /or translation service for applicants when necessary.

(A Chinese speaking relative/friend of the family can be present in the interview to facilitate communication.)

#### **Announcement of Admission Results:**

We will inform parents of the K1 admission results **before 15 December 2024 by post.** 

#### **Registration Procedures**

#### 1. Successful applicants:

Parents should complete the registration procedures for their child from <u>2 to 4</u> <u>January 2025</u> within the Centralized Registration Dates which will be announced by EDB. They should submit the original of the "2025/26 RC" to the kindergarten and pay the registration fee.

(Referring to the 25/26 school year registration fee:

a. half-day class HK \$970; b. whole-day class HK \$1570)

#### 2. Applicants on the waiting list:

Parents should complete the registration procedures for their child according to the date specified by the school. Parents are required to submit the original of the "2025/26 RC" to the kindergarten and pay the relevant registration fee.

- 3. Please be reminded that if parents cannot submit the "2025/26 RC" during registration, the kindergarten may not be able to process registration for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified date.
- 4. The registration fee for 2025/26 half-day and whole-day K1 place is HK\$970 and HK\$1570 respectively. If the child concerned enrolls in our kindergarten, our kindergarten will refund the registration fee after the commencement of school year., If parents, however, decide to change school for their children after registration, please notify the kindergarten in writing. The kindergarten will return the "2025/26 RC" to parents, but the registration fee will **not** be refunded. After the registration certificate (RC) is retrieved, the kindergarten will no longer reserve a place for the child.
